NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

1. Formation of new opening in the churchyard wall immediately west of the south east lychgate. Re-use of the existing curved coping stonework of the churchyard wall adjacent to the lychgate to form the end of the wall adjacent to the new opening
2. Construction of a sloping asphalt, stone edged path with handrails on either side. This path to follow the inside of the churchyard wall and turn at a right angle to the join the existing path a short distance from the lychgate.
3. Construction of a low stone wall at the foot of the side-wall of the lychgate to conceal exposed foundations.
4. Removal of a small shrub and relocation of the church sign to further along the wall.
